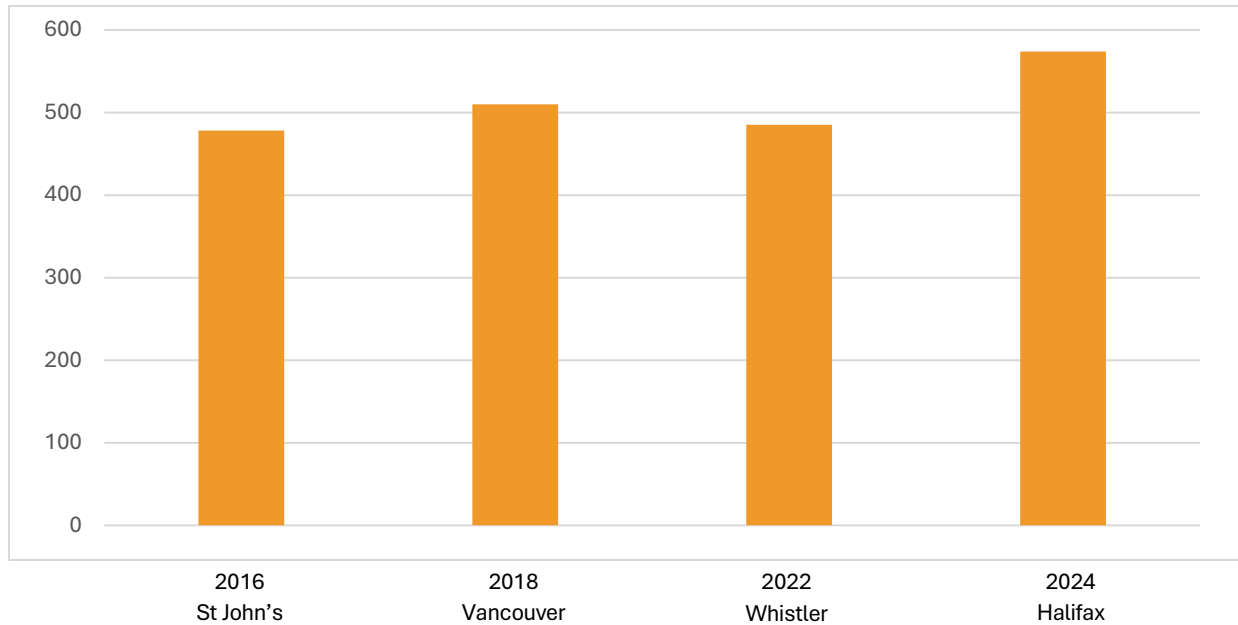

### What does partnership with the NFLP look like?

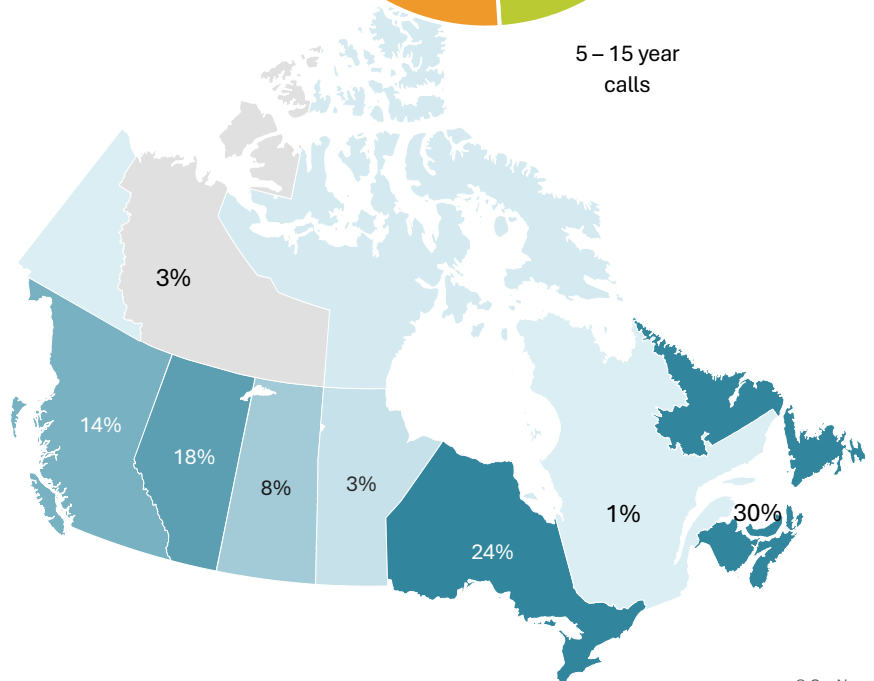
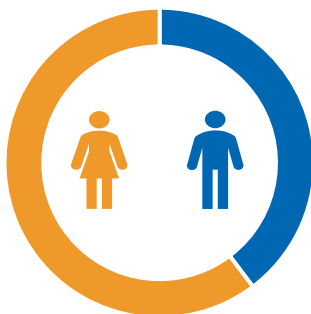
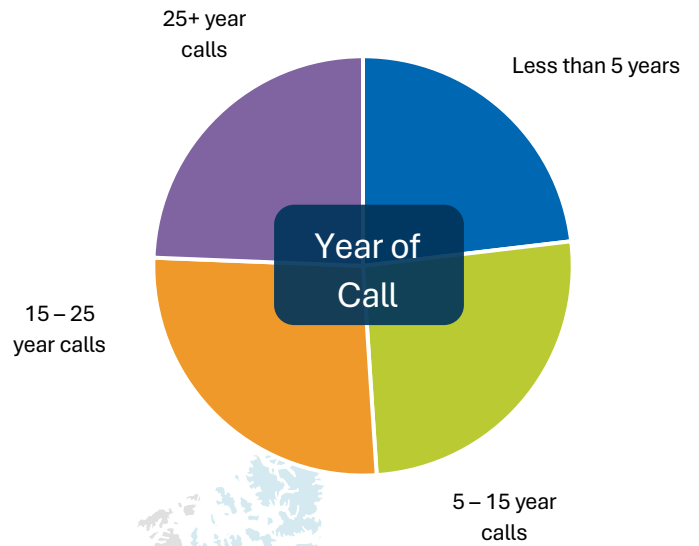
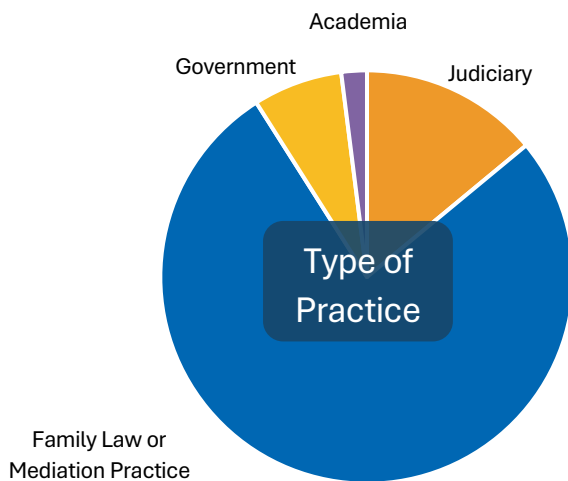

## Quiet Space: \$3,000

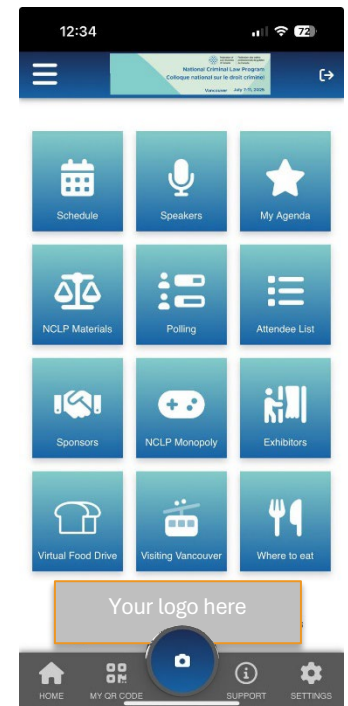

<b>Shipping</b>	Shipping instructions will be provided closer to the conference date. Exhibitor is responsible for their own shipping, handling, storage, event production, and AV costs.
<b>Prize Draws</b>	Exhibitors are encouraged to offer prize draws at their booths. Exhibitors are responsible for timing of their draws and contacting winners as well as arranging for prize collection.  In 2026 we will be introducing a game through the Mobile App whereby attendees who scan QR codes at each of the participating booths will be entered into general draws. Top scorers would receive prizes of varying value dependant on contributions from exhibitors. The NFLP will include a free registration to the 2028 NFLP as a top prize.
